HIGHLY DIVERSE INDEPENDENT SCHOOLS: THE FOUNDATION ESTABLISHED NEW ROADS SCHOOL IN 1995. AS OF JULY 1, 2000, NEW ROADS SCHOOL WAS INCORPORATED IN THE STATE OF CALIFORNIA AS AN INDEPENDENT EDUCATIONAL COMMUNITY SET ON THREE CAMPUSES WITHIN LOS ANGELES COUNTY THAT SERVES STUDENTS IN PRE-KINDERGARTEN THROUGH GRADE 12.

ON DECEMBER 30, 2010, THE FOUNDATION TRANSFERRED TO THE SCHOOL ITS REMAINING 50% INTEREST IN NEW LAND COMPANY. NEW LAND COMPANY WAS THEN DISSOLVED AND ITS ASSETS DISTRIBUTED TO THE SCHOOL, WHICH IS NOW RESPONSIBLE FOR THE CONSTRUCTION OF THE VILLAGE. THE VILLAGE WILL COLLABORATE IN DESIGNING AND IMPLEMENTING REAL SOLUTIONS TO EDUCATIONAL

LENNOX EDUCATIONAL NEIGHBORHOOD ZONE (LENZ): LENZ IS COMMITTED TO PROVIDING MEASURABLE EDUCATIONAL REFORMS IN THE COMMUNITY OF LENNOX, CA. NEW ROADS FOR NEW VISIONS: WITH OVER 30,000 JUVENILE OFFENDERS INCARCERATED IN THREE JUVENILE HALLS AND EIGHTEEN RESIDENTIAL TREATMENT CENTERS (CAMPS), LOS ANGELES COUNTY JUVENILE JUSTICE SYSTEM STANDS ALONE AS ONE OF THE LARGEST DETENTION SYSTEMS IN THE COUNTRY. ACCORDING TO CALIFORNIA'S DIVISION OF JUVENILE JUSTICES, 70% OF YOUTH PAROLED FROM ITS INSTITUTIONS ARE REARRESTED WITHIN TWO YEARS.
